1. Background

Action 9 of the 2014-20120 RTAP for the Mediterranean Region calls upon the EuroMed Partner countries in addition to adhere to and effective implement the main United Nations road transport agreements and conventions, to also participate in the work of main international transport road organizations, such as UNECE.

In this regard the Activity 1A.4 of the EuroMed Transport Support Project aims at supporting participation of EuroMed experts to UNECE intergovernmental bodies. Participation of experts from EuroMed Partner countries to selected UNECE intergovernmental bodies, was facilitated during EuroMed RRU. The present activity is a continuation of that. The general objective of this activity is to allow EuroMed countries continue getting experiences from the work implemented in the UNECE Intergovernmental bodies administering the main UN Road Transport Agreements that would facilitate their efforts of acceding to and implementing them in their respective countries. Six (6) UNECE intergovernmental meetings were proposed to which the participation of EuroMed RRU country experts should be facilitated as follows:

- The Inland Transport Committee (ITC);
- The Global Forum for Road Traffic Safety (WP.1);
- The Working Party on Transport of Perishable Foodstuffs (WP.11);
- The Sub Committee on Road Transport (SC.1);
- The Working Party on the Transport of Dangerous Goods (WP.15);
- The World Forum for Harmonization of Vehicle Regulations (WP.29).

In the year 2017 three events, out of the above six (6) were included in the annual work plan of the project for implementation: the 79th Session of UNECE Inland Transport Committee (ITC) and Ministerial Meeting, 21 – 24 February 2017, the Global Forum for Road Traffic Safety (WP.1), held in Geneva, 19-21 September 2017, and the World Forum for Harmonization of Vehicle Regulations (WP.29), held in Geneva, 14-17 November 2017.

For 2018 year, the work plan included the 80th Session of ITC, held in Geneva, 20-23 February 2018, the 77th Session of the Global Forum for Road Traffic Safety (WP.1), held in Geneva, 18-21 September 2018, the 105th Session of the Working Party on the Transport of Dangerous Goods (WP.15), held in Geneva, 6-9 November 2018, and the 176th Session of the World Forum for Harmonization of Vehicle Regulations (WP.29), held in Geneva, 13-16 November 2018. More UNECE intergovernmental meetings are planned for implementation in 2019 and in 2020.

The present Concept Note concerns the 81st session of the Inland Transport Committee, to be held in Geneva, 19-22 February 2019.

2. The UNECE Inland Transport Committee (ITC)

The Inland Transport Committee (ITC) is the highest policy-making body of the UNECE in the field of transport. During the last 70 years, together with its subsidiary bodies, the ITC has provided a pan-European intergovernmental forum, where UNECE member countries come together to forge tools for economic cooperation and negotiate and adopt international legal instruments on inland transport. These legal instruments are considered indispensable for developing efficient, harmonized and integrated, safe and sustainable pan-European transport systems. Considered as the international best practices, these legal instruments are accepted by many countries worldwide. High transport officials from all UNECE member countries and countries from other parts of the world, together with high representatives from European and International Organizations and transport related institutions, are usually attending the annual sessions of the ITC.

3. Objectives

The general objective of the Activity is to allow EuroMed countries to get experiences from the work implemented in the UNECE Intergovernmental bodies administering the main UN Road Transport Agreements that would facilitate their efforts of acceding to and implementing them in their respective countries.

The specific objectives are to:

- Build capacity to the respective Ministries of the EuroMed partner countries relating to the implementation of the main road transport legal instruments;
- Familiarize EuroMed Partner country high officials with the work developed by UNECE ITC in supervising and managing the main international Road Transport Agreements administered by it;
- Enhance knowledge with the main issues, constraints, requirements and benefits from acceding to and implementing of the main UN road transport Agreements;
- Take part in the process of the negotiation of necessary modification of the respective Agreements and related events;
- Be part of the European and international network of governments and nongovernment experts dealing with the main UNECE road transport Agreements;
- Meet with UNECE and other officials and experts dealing with the relevant issues from the public and private sectors from Europe and beyond.

5. Target Groups

EuroMed country expert's participation in the meeting is limited to one participant, the EuroMed National Coordinator, per country.

While, EuroMed country expert's participation in this meeting, under the project funding, is limited to one participant per country, countries may decide to increase the number of their experts participating, at their own cost.

6. Preliminary Program

The EuroMed countries' National Coordinators or their representatives, whose participation will be supported, will attend the 81st Session of UNECE Inland Transport Committee (ITC), to be held in Geneva, 19-22 February 2019, in the Palais des Nations, starting at 10.00. The 81st annual session of the Inland Transport Committee (ITC) in 2019 is expected to mark a milestone in its history. The Committee is expected to decide on the adoption of its strategy until 2030. The 2019 plenary session will start on 19 February (a.m.), with a high-level policy segment on "Automation in Transport", followed by a governments-only restricted session (p.m.), where the Committee will debate and decide on its Strategy until 2030, to better position it in a fast-changing global policy environment.

The high-level policy segment will be enriched by side events and exhibitions or demonstrations of new technologies related to the automation in transport.

The regular session of the Committee will start on 20 February and for two-and-ahalf-days, important topics on the future of inland transport governance will be discussed. The most important topics to be debated and decided upon include Road





Safety, including the setting up of the United Nations Road Safety Trust Fund; automation; Intelligent Transport Systems, digitalization; e-documents, including eCMR and eTIR; the transport of dangerous goods; border-crossing facilitation and much more.

7. Organization and funding

From the Airport to the Hotel

Before passing the customs control at the arrival search for a "Free Ticket", at the automatic machine, just opposite the luggage claim and <u>before the exit door</u>.

Go to the trains - take the first train going to Geneva (All trains stop first at Geneva (Central Station-named Cornavin Station) - Disembark from the train at Geneva (Cornavin) Station (first stop) and go to Lane 1 (Voie 1) - Take (R-Regio) train direction COPPET - train every half hour (.... 14.02, 14.32, 15.02, 15.32) – Disembark at Versoix – The Lake Geneva Hotel is 200 m behind the Building "Bolero".

From the Hotel to the Palais des Nations, to the City, to the Airport

Go to Versoix Station Lane 1 (Voie 1) and take the (R-Regio) train direction Genève – Lancy – Pont- Rouge - Train every half hour (.... 14.09, 14.39, 15.09, 15.39)

To the Palais des Nations

Disembark at Sécheron – The Palais des Nations is at 5 minutes' walk to your left

<u>To the City</u>

Disembark at Genève (Cornavin Station)

To the Airport

Disembark at Genève (Cornavin Station) - Go to Lane 3 (Voie 3) – Take any train going to the Airport

The Hotel will give you <u>free of charge daily public transport tickets</u> which you can use for all modes of public transport in the city of Geneva (Train, Tram, Bus)
